

# March 13, 2018

## BOARD MEETING

A Town Board Meeting was called to order at 7 pm on March 13, 2018 by Chairman Tony Suda.

Roll call was taken. Present were Chairman, Supervisor Reinart, Supervisor Ken Kuhn, clerk Donna Kuhn, treasurer Shawn Huth, Ed Kuhn, Bill Kuhn, and candidate Lyndsey Boon Brunnette. The agenda was legally noticed and approved.

The minutes from last month's meeting were read by the clerk and approved. Treasurer's report was read by Treasurer. It was accepted. Treasurer left meeting.

No building permits were issued.

Lyndsey Boon Brunnette spoke on her qualifications for Clark County judge. Elections are in April.

Clerk will check on companies to replace coverage from LGPIF that will be ending in June.

Roads will be posted for spring weight limits. Skidders are putting ruts in Ballard Road.

There will be a scoping meeting for the Pray Ave bridge replacement project on April 5 at 10 a.m. at the Town hall with the DOT and Ayers representatives present. Road inspection by Board will be at 1:00 pm that same day.

**Suda moved / Reinart 2<sup>nd</sup>, that Driveway Ordinance 2005-5, Section 1.04 (1) be amended from 16' finished surface to 24 feet finished surface. All – yes. Carried.**

**Kuhn moved / Suda 2<sup>nd</sup>, that an extension be put on Russ Smith's driveway for a bus turn-around. All – yes. Carried.**

Beaver contract will be tabled for more discussion.

No change will be made with the building permit procedure for now. Ed will refer new house dwellings to Adam Pillard for inspection.

Possible annual meeting agenda items were discussed. They will be: appoint clerk / treasurer position, wages, Road work for 2018.

Bills approved and paid.

Public Input: Kelly Reinart asked Board for permits for trucks hauling to and from Reinart Dairy during the spring weight season. **Suda moved/ Kuhn 2<sup>nd</sup>, to issue permits for trucks hauling to and from Reinart Dairy. Suda – yes, Kuhn – yes, Reinart – abstained. Carried.** After further discussion, **Suda moved / Kuhn 2<sup>nd</sup>, to rescind the previous motion. Carried. Suda moved / Kuhn 2<sup>nd</sup>, that the spring weight limit for Pray Ave north of Hwy 73 start at driveway N2140 Pray Ave. Sign will be put north of said driveway. This will allow truck traffic from Hwy 73 to Reinart Dairy, LLC. Suda – yes. Kuhn – yes. Reinart – abstained. Carried.**
